Our Mission

The mission of the Lehigh County Court-Appointed Special Advocate (CASA)
Program is to provide consistent, credible and trained volunteers who investigate, facilitate, monitor and advocate for Lehigh County's abused and neglected children in juvenile dependency court. These CASA volunteers serve as the "eyes and ears" of the Court. Input from these dedicated CASA volunteers assists the Court in making sound decisions that will provide safe, secure, and permanent homes for atrisk children.

Qualifications

- Volunteers must be at least 21 years of age and pass criminal history record checks (paid for by Lehigh County CASA).
- Volunteers must have good verbal and written communication skills.
- Possess the ability to be objective and non-judgmental.
- Commit to being a volunteer for 18 to 36 months, the average time a child's case is open in the Juvenile Dependency System.
- Must be available to attend all court hearings.

Help Us Reach Every Child

- 25,381 children are in foster care placement statewide.
- 396 children are in foster care placement in Lehigh County.
- 64% of those children are placed in non-relative family homes.

Currently, there are **44 CASA volunteers**, serving **88 children** in Lehigh County.

Become a CASA Volunteer

- Complete an application and interview with CASA staff.
- Complete 40 hours of free, preservice training.
- Pass criminal history checks.
- Be sworn-in by a judge.

Duties of a CASA Volunteer

- Visit the child.
- Gather information from everyone in the child's life: parents, foster parents, social workers, medical providers, teachers, etc.
- Review records.
- Build positive relationships with team members.
- Maintain confidentiality.
- Prepare written reports, attend court hearings, and related meetings.
- Ensure the child's wishes are known to the judge.
- Advocate on behalf of the child's best interests.
- Remain committed to the child's case until permanency is achieved.
